Privacy Policy

Raise A Barn, LLC (“RaiseaBarn”) has established this Privacy Policy (“Privacy Policy”) in order to demonstrate our firm commitment to privacy and to explain to you how your personal information obtained through your use of www.RaiseaBarn.com (the “Website”) is processed and used on this Website. RaiseaBarn uses your personal information only in ways that are compatible with this Privacy Policy. In addition to reviewing this Privacy Policy, please read our Terms of Services (“TOS”). This Privacy Policy does not cover information collected on sites linked to from the Website.

This Privacy Policy may be updated by RaiseaBarn from time to time. RaiseaBarn will provide notice of materially significant changes to this Privacy Policy by posting notice on the RaiseaBarn site. Continued access of the Website by you will constitute your acceptance of any changes or revisions to the Privacy Policy.

1. Consent

By using our Website and our services, you consent to the terms and conditions of this Privacy Policy.

2. Protecting your privacy

- To enroll you have to provide us with your name and email address and you are no longer anonymous to us.
- Account information is password-protected. Keep your password safe.
- Forums use basic web server authentication. Close your browser to log out.
- RaiseaBarn complies with the Children’s Online Privacy Protection Act and will not knowingly collect any personally identifiable information from anyone under the age of 13. If RaiseaBarn learns that a posting is by a person under the age of 13, RaiseaBarn will remove that post.

3. Data we collect

- We may collect your email address, for purposes such as sending self-publishing and confirmation emails, authenticating user accounts, providing subscription email services, registering for forums, etc.
- For offers and needs, we collect contact information, such as name(s), zip code(s).
- We may collect your phone number for account authentication purposes.
- RaiseaBarn does not store credit card information. Credit card transactions are transmitted to a financial gateway and we endeavor to protect the security of your payment information during transmission by using Secure Sockets Layer (SSL) technology.
- When you enroll with RaiseaBarn we collect personal information such as your full name, address, city, zip code, state, phone number and email address. Any information entered into an offer or need is public information to the domain you chose for that specific offer or need. Please do not post any personal information anywhere on RaiseaBarn that you expect to keep private.
- Our web logs automatically collect standard web log entries for each page served, including your IP address, page URL, and timestamp. Web logs help us to diagnose problems with our server, to administer the RaiseaBarn site, and to otherwise provide our service to you. We use this information for no other reason.

4. Data we store

- All offers and needs are stored in our database, even after "deletion," and may be archived elsewhere.
- Our web logs and other records are stored indefinitely.
- Registered profile users can access and update their account information through "Edit My Profile".
- Although we make good faith efforts to store the information in a secure operating environment that is not available to the public, we cannot guarantee complete security.

5. Order Forms

- Our site uses an order form for customers to request services. (128 bit encryption). We collect sensitive information which is used only for our purpose. No third party receives any type of information from us. Contact information from the order forms is used to get in touch with the customer when necessary. Billing information that is collected is used to bill the user for services. Unique identifiers are collected from Website visitors to verify the user's identity. Demographic and profile data is also collected at our site. We use this data to tailor our visitor's experience at our site showing them content that we think they might be interested in, and displaying the content according to their preferences.

6. Circumstances in which RaiseaBarn may release or preserve information

- RaiseaBarn may preserve or disclose information about its users if required to do so by law or in the good faith belief that such preservation or disclosure is reasonably necessary to respond to subpoenas, court orders, or other legal process.
- RaiseaBarn may also preserve or disclose information about its users to law enforcement officers or others, in the good faith belief that such preservation or disclosure is reasonably necessary to: enforce our TOS; respond to claims that any posting or other content violates the rights of third-parties; respond to claims that contact information (e.g., phone number, street address) of a third-party has been posted or transmitted without the third-party's consent or as a form of harassment; or protect the rights, property, or personal safety of RaiseaBarn, its users or the general public.
